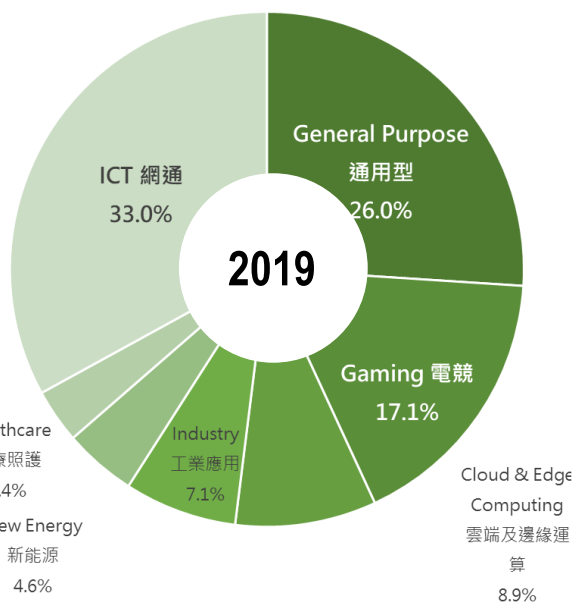

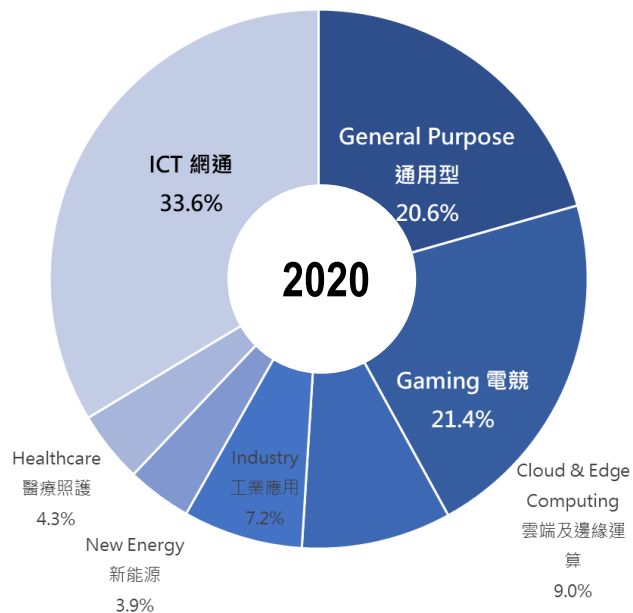

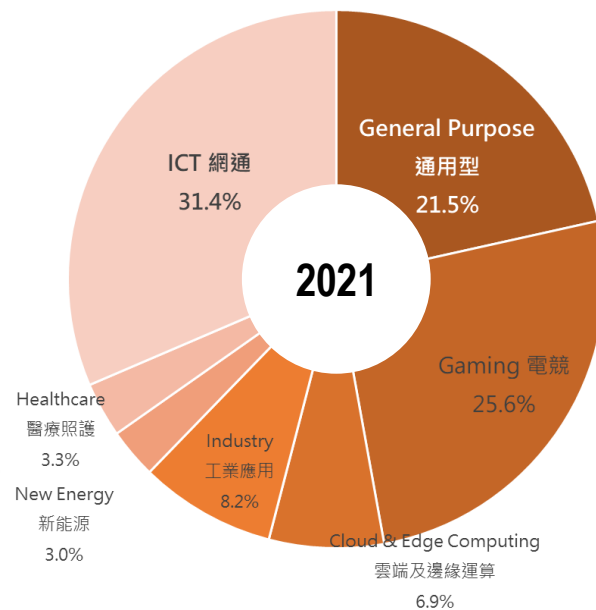
2019~2021 應用佔比 Application Percentage

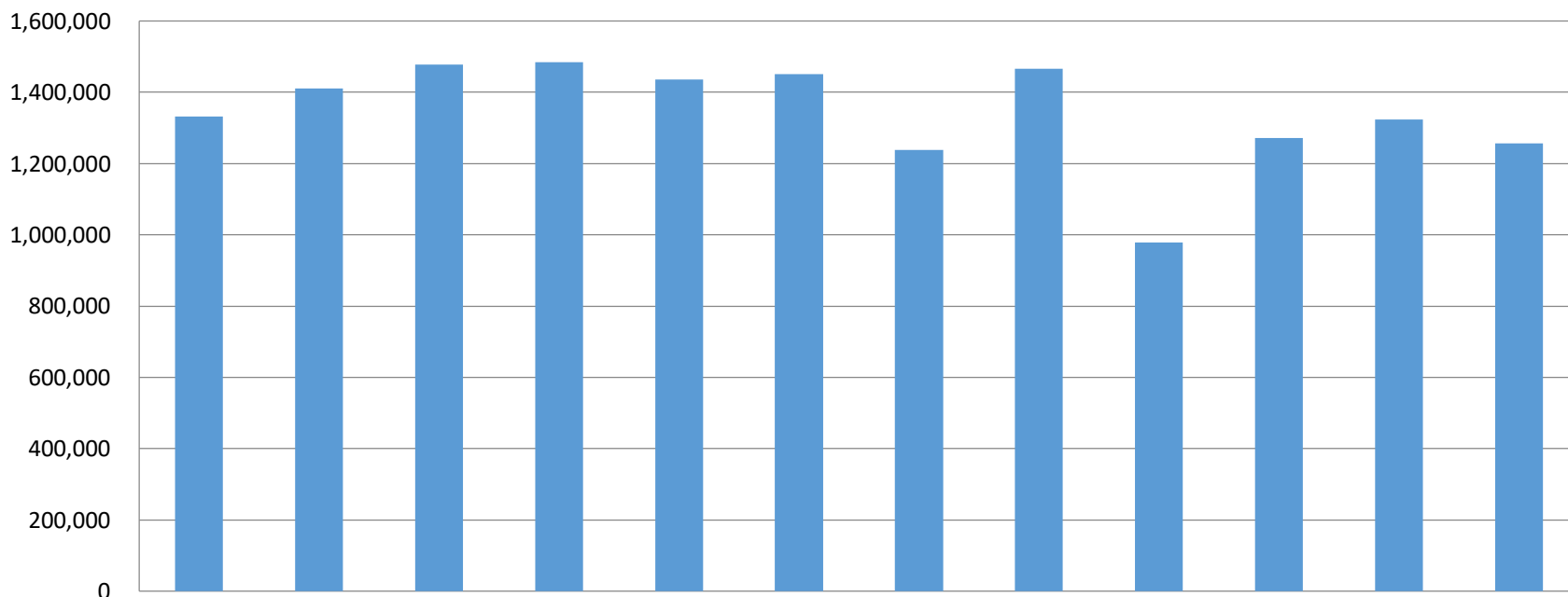
